WHEREAS, the Department of Transportation-Land Transportation Office (DOTr-LTO) issued Memorandum Circular (MC) 2019-009, "Revised Guidelines for the Authorization of Private Motor Vehicle Inspection Center (PMVIC)" dated 13 March 2019.

WHEREAS, pursuant to Section 2(D) of said MC, one hundred thirty-eight (138) PMVIC sites were initially identified based on strategic location, accessibility, catchment areas, and number of registered vehicles.

WHEREAS, Section 2(G) of MC No. 2019-009 provides that the PMVIC Authorization Committee (AC) shall have the discretion to evaluate the areas where additional PMVICs should be established taking into account the number of registered vehicles in coordination with LTO.






